2010 TRAIL TRIALS SENSORY TRAINING and MEMORIAL COMPETITION

DATE: **June 4th & 5th, 2010** (*Entry Deadline May 28th, 2010*)
Registration Friday June 4 @ 1200-1800 hours and Saturday June 5 @ 0700-0900 hours.

Trail Trials Sensory Training and Competition will be held on Saturday, June 5 @ 0900.

LOCATION: Modesto Police Dept training site, 3000 W. West Main, Patterson, CA.

From Hwy. 99 take the West Main off ramp and travel west approx. 6 miles. When you pass Carpenter Road begin watching for signs at the south side of the roadway. The entry to the site is approx. ¼ mile past Carpenter Road.

HOSTED BY: CMOA and the Modesto Police Department Mounted Unit.

COURSE DESCRIPTION: The Trail Trials Sensory Training and Competition is a trail course consisting of challenging sensory objects designed to test the tactics and skills of the mounted police officer and the law enforcement mounted volunteer, and his/her mount. The course is designed to build confidence for both the rider and the equine partner. Law Enforcement Mounted Units may compete as a team (4-riders) representing their agency or, on an individual basis. Law Enforcement mounted volunteers are happily invited and encouraged to compete!!!

This is the first year the competition has been open for a citizen's division. Come and show off your bomb proof horse!

TRAIL TRIALS CLASS SIZE: 50 Riders Maximum (*Don't Be Left Out – Register Early!*)

SAFETY EQUIPMENT: RIDING HELMETS ARE STRONGLY ENCOURAGED BUT ARE NOT MANDATORY.

SPECIAL EVENTS: SATURDAY NIGHT BARBECUE AND AWARDS CEREMONY. (**Barbecue** dinner tickets \$20 each).

Poker Ride

Friday and Saturday nights there will be a Poker Ride hosted by Modesto Police Dept Mounted Unit. The Poker Ride will begin at 1830 hours both nights.
